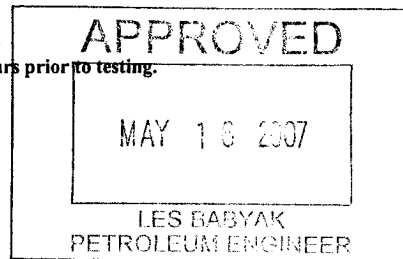

13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. On May 5, 2007 the lease water production increased 100-125 BWPd. After investigation it was determined the #6 was flowing out the annulus. The well was shut-in and casing pressure had built-up to 400 psi by Wednesday May 9, 2007. We plan to:

1. Flow well down to a frac tank.
2. P.O.H. with rods, pump and tubing.
3. T.I.H. with a casing scraper and clean casing.
4. T.I.H. and set a 5 1/2" CIBP at 4761', 50' above perforations (Perfs 4811-5015')
5. Cap CIBP with 35' of cement, using a dump bailer.
6. Test casing at 500 psi for 30 minutes, record pressure on a chart. The OCD will be notified 24 hours prior to testing.
7. T.A. well until further evaluation.
