

ConocoPhillips, per the following procedure, proposes to place a Cast Iron Bridge Plug over the Tubb in order to isolate Blinebry production.

- Move in and rig up pulling unit.
- Trip out of the hole with the rod string and tubing.
- Pick up a 5-1/2" cast iron bridge plug and trip-in to set @ 6550' (22' above the top Tubb perforation)
- Pressure test the CIBP to 1000 psig.
- Re-run tubing and rod string.
- Place the well on to production as a single-zone completion within the Blinebry.
