Kickoff Point @ 3000' MD RKB instead of 4150' MD RKB
Return to vertical to be @ 4950' instead of 6101' MD RKB
Formation Entry Point and Proposed Bottomhole location will remain unchanged.

This change allows completion of the directional steering work and return to vertical before reaching 5000' M.D. (potential loss/seepage zones requiring LCM have historically been >5000' in this area).
