MI x RU. NU BOP. RIH with 5-1/2" CICR x set at 3960'. RU HES x squeeze perfs at 4085' - 4252' with 250 sx. Premium Plus, 2% CaCl. WOC. RIH with 4-3/4" bit x drill out CICR and cement to 4300'. Circulate hole clean. RIH with 16 jts. 4-1/2", 11.6#, Ultra-FJ liner and set at 3606' to 4321'. RU HES and mix x pump 100 sx. Premium Plus. RD HES x WOC. RIH with 4-3/4" bit x tag at 4321'. RU Schlumberger x run CBL from 4316' - 3500'. Perforate at 4078'-80', 4088'-90', & 4127'-30', 1 JSPF (10 holes) and 4150'-52', 4157', 4167', 4177'-78', 4189', 4196'-98', 4208'-10', 4226'-31', 4238'-40', & 4248'-50', 2 JSPF (52 holes). RIH with PPI tool and acidize 4078' - 4250' with 1890-gal. 15% HCL. RIH with 4-1/2" packer on 122 jts. 2-7/8" duoline injection tubing (packer set at 3995'). Circulate hole clean with 110 bbls. 10# packer fluid. ND BOP x NU WH. Pressure test casing to 600 psi x 30 min. Turn well over to injection. RD x MO x clean location.
