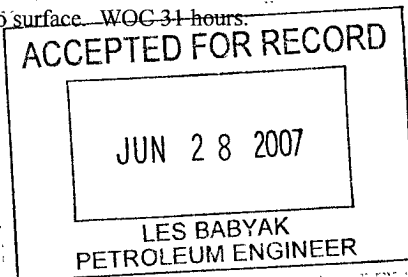
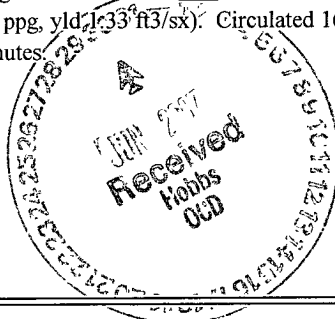
12.16.06 Spudded 17-1/2" hole.

12.17.06 Ran 494' 13-3/8" 48# H-40 STC casing. Cemented with lead of 240 sx Halliburton Light Premium Plus + 2% CaCl + 0.125# Poly-E-Flake (wt 12.5 ppg, yld 1.98 ft3/sx) and tail of 150 sx Premium Plus + 0.125# Poly-E-Flake + 2% CaCl (wt 14.8 ppg, yld 1.34 ft3/sx). Circulated 91 sx to surface. WOC 27.75 hours.

12.18.06 Pressure tested 13-3/8" casing to 1000 # psi for 30 minutes.

12.28.06 In 12-1/4" hole, ran 3720' 8-5/8" 32# J-55 LTC casing. Cemented with lead of 1015 sx Interfill C (wt 11.9 ppg, yld 2.45 ft3/sx) and tail of 200 sx Premium Plus + 1% CaCl (wt 14.8 ppg, yld 1.33 ft3/sx). Circulated 163 sx to surface. WOC 31 hours.

12.30.06 Pressure tested 8-5/8" casing to 1000 # psi for 30 minutes.
