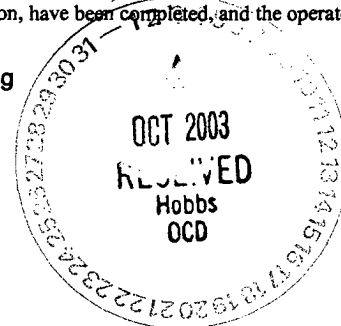

  3. Set 100' Plug at 925'-1025' balanced 50' inside and 50' outside casing shoe with 25 sacks cement. Tag top of cement.
  4. Set 60' Surface Plug with 15 sacks cement.
  5. Set Dry Hole Marker.
  6. Clean and reclaim location.
- Anticipate operations to begin by 10/1/2003.
