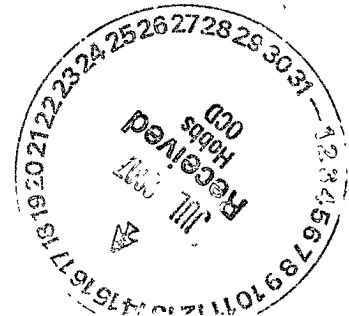

4. Acid treat well w/4000 gal of 15% PAD acid.
5. Perform scale squeeze.
6. Run back in hole w/ESP equipment.
7. Return well to production.
