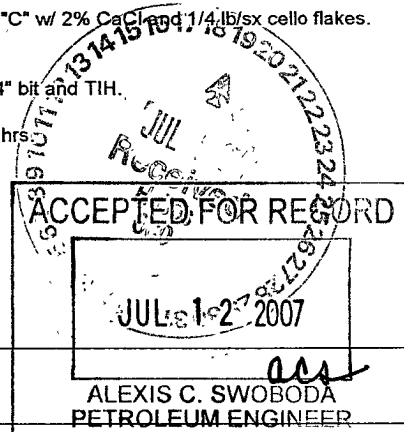

7/09/07: WOC 12 hrs before cut off csg. NU csg head and NU BOP. Tested BOP to 650 psi - OK. PU 12 1/4" bit and TIH.

7/10/07: Cleaned out cement to csg shoe, started drilling 12 1/4" hole @ 5:00 AM. Total WOC time - 34 3/4 hrs.
