1. Move in and rig up. POOH with rods and pump.
2. Swab well. Check for production and fluid level.
3. Install B.O.P. POOH with tubing.
4. Perforate additional pay in Ramsey Sand.
5. TIH with frac tubing and packer.
6. Rig up BJ. Frac well.
7. Flow and swab test well.
8. Put well on production.
9. Clean location. Rig down. Move out.
