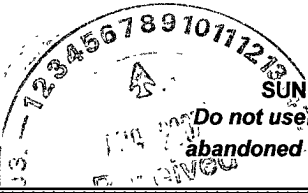

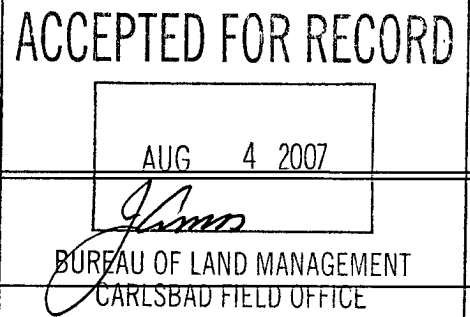
13. Describe Proposed or Completed Operation (clearly state all pertinent details, included estimated starting date of any proposed work and approximate duration thereof. 02.19.07 Spudded 17-1/2" hole. Ran 460' 13-3/8" 48# H-40 STC. Cemented with lead of 250 sx 35/65 POZ C + 6% D-20 + 3% S-1 + 5 pps D-24 + 0.125 pps D-130 (wt 12.6 ppg, yld 1.93 cf/sx) and tail of 200 sx Class C + 2% S-1 + 0.125 pps D-130 (wt 14.8 ppg, yld 1.32 cf/sx). Circulated 142 sx to pit. WOC 16.75 hrs.

02.20.07 Pressure tested 13-3/8" casing to 1000 # psi for 30 minutes.

02.26.07 In 11" hole, ran 3504' 8-5/8 #32 J-55 LTC.

02.27.07 Cemented with lead of 1039 sx 50/50 POZ C + 5% D-44 BWOW + 10% D-20 + 5 pps D-24 + 0.125 pps D-130 + 0.2% D-46 (wt 11.9 ppg, yld 2.47 cf/sx) and tail of 225 sx Class C + 2% S-1 (wt 14.8 ppg, yld 1.34 cf/sx). Circulated 221 sx to pit. WOC 27.25 hrs. Pressure tested 8-5/8" casing to 1000 # psi for 30 minutes.
