COG Operating LLC proposes to recomplete to Delaware & test.

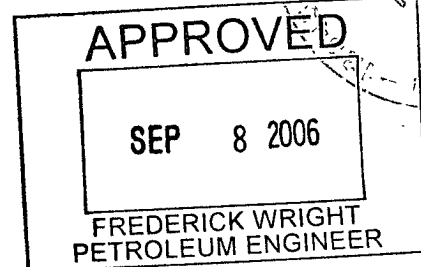

The proposed intervals are as follows:

Bootleg Ridge; Delaware, NM 8420' - 8448'
Red Tank; Bone Spring 8792' - 8830'

Ownership in all zones is the same.
