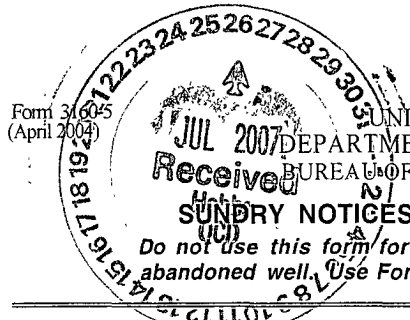

- 3. Pump 25 sx C cmt @ 1,850' (top of salt)**
- 4. Perforate & squeeze 50 sx C cmt 354 - 254'. WOC & TAG**
- 5. Pump 25 sx C cmt 100' to surface**
- 6. Cut off wellhead & anchors, install dry hole marker**
