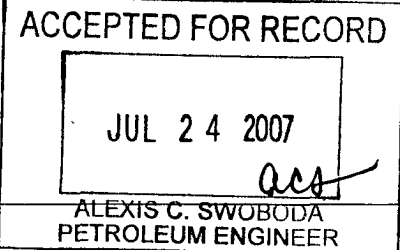
7-14-07: TD'd 12-1/4" hole @ 12:15AM, notified Paul Swartz of intent to run csg. Ran 88jts 8-5/8" 32lb J-55 LT&C csg to 3750'.

7-15-07: Cemented csg w/ 1300 sxs BJ Lite 35/65 Poz w/ 5% salt, tailed-in w/ 200 sxs Class "C" w/ 1% CaCl. Plug down @ 8:10AM. Circ'd 200 sxs to pit. WOC 22 hrs - could not set slips, cutoff 13-3/8" head and welded on 8-5/8" head.

7-16-07: Replaced first set of BOP's, re-tested as per BLM (Paul Swartz).

7-17-07: TIH w/ bit to tag cement @ 3750', tested csg to 1500 psi. Drilled out cement and started drilling new 7-7/8" hole @ 4PM.
