08-20-03: Rigged up Apollo Wireline truck and RIH with 5½" CIBP to 7615'. Plug sat down on casing collar at 7616'. Pulled up from collar and set Plug at 7610'. Made 2 bailer runs and dumped 35' of cement on top of plug. Rig down Apollo.

09-05-03: Notified BLM of impending casing test on 9-03. Loaded casing with inhibited water. Pressured up on casing to 540 psi and tested it for 30 minutes. Test witnessed by Stan Mayo of the BLM. Bled off pressure and SI well.

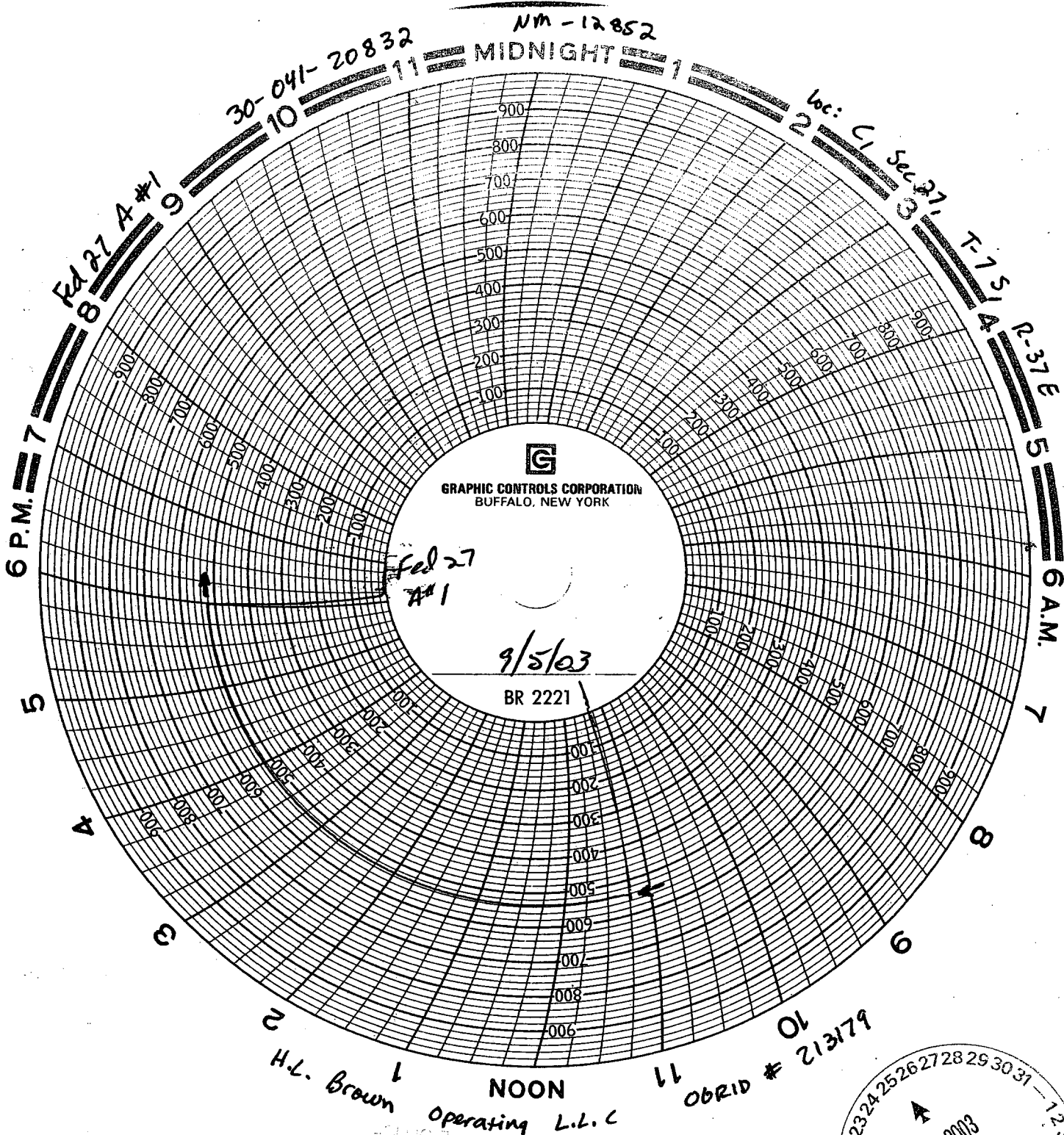
