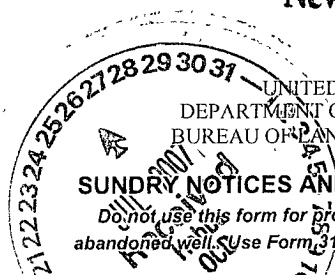

6/22/07 Circulated 10# MLF. Spotted 25 sxs cement @ 2,650'- 2,410'. Perforated @ 1,150. Set packer at 1,050'. Have communication into 5 1/2" csg. Called Gerry Gurley, BLM, and spotted 25 sxs across perms with annulus closed, as instructed. Perforated at 435' and pumped 166 sxs down 5 1/2" csg. Circulated cmt out of 5 1/2" csg around 8 5/8" annulus. Left csg full of cement. Removed wellhead and anchors. Installed P&A marker and backfilled cellar.
