1. Approval is granted to reclaim the referenced location as per Notice of Intent, with the following additions.
2. Remove two power poles on the northwest edge of the location.
3. Salt impacted soils are located on the south side of the location, in the reserve pit area, and just to the north of the reserve pit. These areas are to be addressed during reclamation either by removal down to an acceptable level, buried as per standard pit reclamation with three feet of clean material , or capped with three feet of clean material (2' of caliche and 1' soils similar to the surrounding), and contoured to blend with the surrounding landscape.
4. Reseed all disturbed areas with seed mixture #3.

All work is to be completed within 90 days of authorization, contact Jim Amos at 505-234-5909 if you have any questions, prior to start of reclamation and again at completion, prior to seeding.
