Legacy Reserves Operating, LP (240974) requests a 6-month extension to the NMAC Rule 19.15.2.50 (Section 50, F, 1) regarding closure of drilling pits for wells that Legacy drilled earlier this year in 2007 within our Langlie Mattix Penrose Sand Unit.

Due to un-characteristically heavy and frequent rainfall in May, June, July and August (to date) of this year we have had difficulty in drying out these drilling reserve pits. Subsequently, we have elected to defer removal and site remediation of these pits.

We are currently actively discussing pit closure procedures, timing and costs with several service companies with which we intend to contract to perform this pit removal. And, it is our earnest intention to initiate this work within next 30-60 days, weather permitting.

For your information, we prudently emptied and removed drilling fluids from each pit in a timely manner following drilling and completion of each well in order to minimize the potential of any liquid migration from each pit.

Attached is a listing of each well and significant dates that we are requesting this extension for.
