07/02/2003: Ran 96 joints, 3969', of 5 1/2" 17# J55 casing. Cemented with 815 sacks 35/65 Poz C and 200 sacks Class C. Casing shoe at 4099'. Circulated 66 sacks cement to pit. Plug down at 10:45 AM. WOC. Released rig at 1:00 PM. Waiting on completion.
