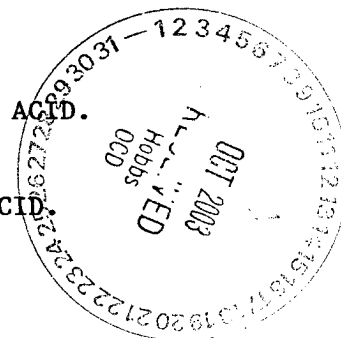

5. ACIDIZE THE WOLFCAMP @ 9884' - 9910' W/ 2500 GAL NEFE 15% HCL ACID. SWAB/FLOW TEST.
