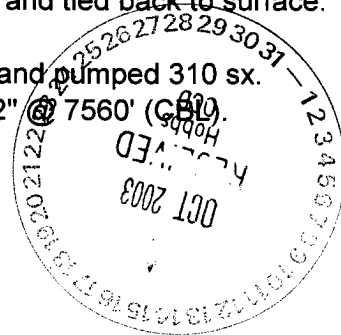

9-22-03 Set 4-1/2" composite plug @ 13250'. Set 4-1/2" cement retainer @ 11000' and pumped 310 sx. Drilled retainer and cement. Drilled out composite plug @ 13250'. TOC behind 4-1/2" @ 7560' (C810).
