- Spot 25 sx cement plug from 4800' to 4700'
- Spot 25 sx cement plug from 2800' to 2700'
- Spot 25 sx cement plug from 427' to 327'.
- Spot 25 sx cement plug from 100' to surface.
- Cut off casing and weld on P&A marker. Clean and restore location.
