

This well is currently producing out of Drinkard perms fr/6480-6780.

Apache proposes to recompleat this well to include the Blinebry via the following procedure:

1. MIRU pulling unit. Pull rods and tubing. Run bit and scraper to PBTD.
2. Run logs for engineer evaluation.
3. Acidize Drinkard zone.
4. Perforate Blinebry at interval chosen by engineer.
5. Set RBP @ +/- 6200' to isolate new Blinebry perforations.
6. Acidize and fracture stimulate Blinebry perforations.
7. Pull RBP.
8. Install production equipment.
9. RWTP from Blinebry/Drinkard in the pre-approved Eunice; Blinebry-Tubb-Drinkard, North pool
