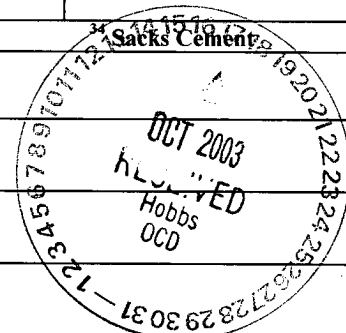

BILL OF SALE AND AGREEMENT

FOR A GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, Mobil Producing Texas & New Mexico, Inc. ("Mobil") hereby conveys to The Wiser Oil Company ("Wiser"), a Delaware corporation with a place of business at 8115 Preston Road, Suite 400, Dallas, Texas 75225, all of Mobil's right, title and interest in and to the wellbores of the Mescalero Ridge Wells #2 and #3 located in Section 17, Township 19 South, Range 35 East, Lea County, New Mexico, (the #2 Well being located 660 feet from the North line and 1580 feet from the West line and the #3 Well being located 660 feet from the South line and 660 feet from the West line), together with any equipment (surface and subsurface) and/or fixtures (surface or subsurface) associated with such wellbores, including without limitation any downhole casing or tubing (herein called the "Assigned Property").

Wiser hereby agrees to plug and abandon the above-described Mescalero Ridge Wells #2 and #3 in accordance with any applicable laws, orders or regulations.

Notwithstanding any provision of this Bill of Sale and Agreement to the contrary, Mobil hereby agrees to indemnify, defend and hold harmless Wiser from and against any claims, losses, demands, damages or liabilities, including without limitation reasonable attorneys' fees (herein called "Damages"), Wiser may suffer or incur by virtue of (a) plugging and abandoning the above-described wells, and/or (b) entering upon any lands for the purpose of plugging and abandoning the above-described wells, to the extent any such Damages arise as a result of a prohibition contained in a contract or otherwise imposed by law against Mobil (or its successor, Wiser) entering upon such lands and/or plugging the above-described wells.

This Bill of Sale and Agreement is made expressly subject to that certain Purchase and Sale Agreement dated July 1, 1993 by and between Mobil Exploration & Producing U.S. Inc., as Seller and The Wiser Oil Company, as Purchaser.
