

4. Perf 4 holes Z-String @ 2600, sqz 70sx, plug 2600-1350 (B-Salt, Yates) WOC Tag.
5. Cut 2 7/8" csgs @ 1350, L/D csgs.
6. Spot 70sx, plug 1350-1100 (8 5/8 shoe, T-Salt) WOC Tag.
7. Displace hole w/MLF, 9.5# Brine w/25# gel P/BBL.
8. Spot 75sx, plug 250-Surf (Surf) WOC Tag.
9. Install dry hole marker.
