AMMENDED REPORT

Apache purchased this well from Capataz Operating. Capataz previously obtained approval to set a CIBP over the Abo. Upon taking over operations, Apache examined well records and it appears that the Abo is open with fish consisting of pkr and tbq stuck @ +/- 7260'. Top Abo perf is @ 7330'. Apache now proposes to abandon the Abo via the following procedure.

1. RIH w/ CIBP and set @ +/- 7240'.
2. Set 35' cement on CIBP.
3. RWTP from Blinbry/Tubb/Drinkard.
