Marathon Oil Company is proposing to temporarily abandon the McDonald State A/C 2 No 31. Marathon had filed previously to recomplete the McDonald State A/C 2 No 31 to the Tubb formation. We wish to keep this our contingency for this well. Due to the number of open Eumont perforations, Marathon wishes to delay this well work until we have had time to evaluate the success of a more viable completion (McDonald State A/C 2 No 30) in this area. Marathon will pull the tubing in the McDonald State A/C 2 No 31 and set a CIPB approximately 100' above the top Eumont perforation @ 2648'. The casing will then be tested to 300 psi.
