Field operations began February 13, 2007

POOH with tubing, set packer at 5742' and tested casing, circulate through perforations 2BPM at 1100 psig.

Squeeze with 400 sacks cement (5790' to 6011') 100 psig at 1.8 BPM, slurry 14.9#/gallon, shut in and wait on cement.

Tested cement squeeze to 500 psig, tested OK.

Drilled cement and cleaned out to 6202', set on something solid, drilled on junk with well on vacuum.

Trip in hole to 6050', set packer and tested backside to 500 psig, O.K.

Set packer at 5780' and tested, determined a hole in 7" casing at 6065' K.B.
