Perf 300' w/4 spf to penetrate the 5" and 7" casing. Set cement retainer @ 200' and circulated 150 sacks cement between the 7" and 12-1/2". Cap w/ 10 sacks class C cement f/0-10'. Installed P&A marker and cut off wellhead.
