5. Spot 90sx, plug 1400-1100 (8 5/8 shoe, Stub, T-Salt) WOC Tag.
6. Displace hole w/MLF, 9.5# Brine w/25# gel P/BBL.
7. Spot 75sx, 250-Surf (Surf) WOC Tag.
8. Install dry hole marker.
