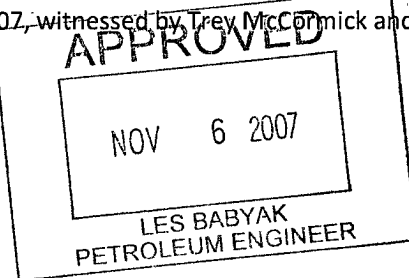
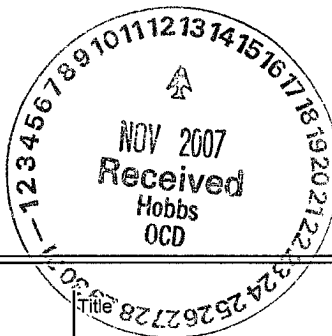

Well is currently TA with CIBP @ 3090' in Langlie Mattix; 7 Riv-Q-Gbg. Well has Rhodes; Yates (Gas) potential @-2550'-2850.' A recompleat of this well is not in the budget at this time. Plugging this well and leaving Yates potential behind would be economically wasteful, so we are requesting continued TA status. Enclosed is an MIT chart run on 10-16-07, witnessed by Trey McCormick and Pat McKelvey of the BLM Hobbs office.
