05-14-07 In 17-1/2" hole run 13-3/8" H-40 48# ST & C @ 314'. Cement w/ lead of 50 sx Prem Plus + 1% Ca Cl + .125 # Poly-E Flake (wt 12.5 # yield 1.97) and tail of 220 sx Prem Plus + 2% Ca Cl (wt 14.8 # yield 1.34). WOC 15.5 hours and test casing to 1000 psi for 30 minutes.
5-24-07 In 12-1/4" hole run 9-5/8" N-80 40# LT & C @ 4740'.
5-25-07 Cement w/lead of 1225 sx Interfill C + .125 # Poly-E-Flake + 1% Ca Cl (wt 11.9 # yield 2.45) and tail of 250 sx Prem Plus + 1% Ca Cl (wt 14.8 # yield 1.33). Circulate 11 sx to pit. WOC 16 hours. Test casing to 1000 psi for 30 minutes.
