BTA Oil Producers respectfully requests permission for off-lease movement, after measurement, of hydrocarbons. This is a one-time request. Our intent is to put together smaller volumes at one central location in order to make a full load for transporter pick up, rather than have small volumes of stock at individual locations that sit for extremely long periods of time. Future production will continue to be measured and stored on each individual location. The basis of this request is to prevent waste and to be able to take advantage of current market pricing. The production from each lease will be measured accurately by gauging and will be documented at both locations prior to and after transporting. With such accurate record-keeping, we do not anticipate payout complications. We believe that, by moving the measured hydrocarbons to a central point for sale, we are not hurting the value of production.
