

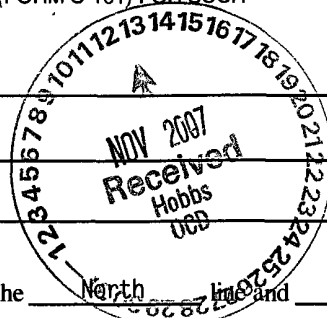

10-31-07 POOH w/ tbq. RIH w/ CIBP. Set CIBP @ 2600'. (top Eumont perf @ 2648') laid down 1 jt tbq. Circ hole w/ pkr fluid. Pressured up CIBP and casing to 550 psi. POOH w/ tbq. Install wellhead.
11/01/07 Pumped 1/2 bbl pkr fluid to load annulus. Found casing valve not holding. Changed out casing valve. Pressured up to 580 psi for 30 minutes, ended test w/ 576 psi on well head and casing. Please see attached pressure chart.
