Contour to match landscape. Remove oil stained dirt from pad and address any other environmental issues that might arise during clean up of old battery site. First letter of non-compliance.

Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well. Such a hearing may result in imposition of CIVIL PENALTIES for your violation of OCD rules.
