10-18-07: Drilled out DV tool @ 7538' and cleaned out to PBTD.

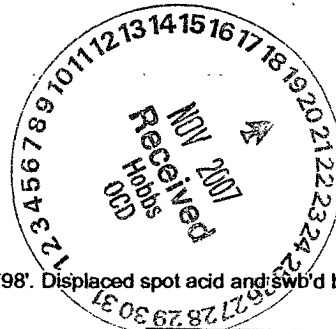
10-19-07: Spotted perf acid, TOH w/ bit. Ran GR-CBL-CCL from PBTD to 7000'.

10-24-07: Acidized perfs w/ 2000 gals NEFE w/ 75 balls. Started swb'g back load water.

10-25-07: Swab testing perfs.
