Request approval to recompleat well from the Blinbry-Tubb to the Lower San Andres.

It is planned to isolate the Blinbry-Tubb with the existing CIBP set @ +/- 5785' ; adding 35' cement on top; then perforate the Lower San Andres @ 5020-5035', 5116-5126' (20 holes), 5212-5222' (20 holes), 5234-5240' (12 holes) & 5310-5320' (20 holes) and fracture-treat.

Pits will not be utilized, therefore, a pit permit will not be applicable.
