Comments on Inspection: Well Sign has incorrect operator. Need to install new well sign with correct lease information (see Rule 103). First letter of non-compliance.

Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well. Such a hearing may result in imposition of CIVIL PENALTIES for your violation of OCD rules.

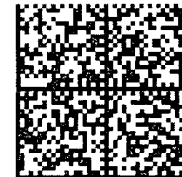
