

**Comments on Inspection:**

Well Sign (Rule 103). UNABLE TO READ SIGN AT WELL, NEED TO REPLACE SIGN AT WELL AND TANK BATTERY. NEED TO REMOVE SURPLUS OR JUNK EQUIPMENT FROM WELL AND TANK BATTERY. RULE 114. THIS INCLUDES BUT NOT LIMITED TO THE FOLLOWING: HEATER TREATER, CONCRETE BASES, SECTION OF TANKS, GRADE BANDS, FENCING, WALKWAYS, UNLABELED DRUMS, USED PIPING AND OTHER MISC. JUNK. OIL CONTAMINATED SOIL MUST BE REMOVED FROM AROUND WELLHEAD. RULE 114. REPAIR ROADS TO AVOID DRIVING INTO PASTURE. RULE 114. THIS IS 1ST LETTER OF NON-COMPLIANCE.

In the event that a satisfactory response is not received to this letter of direction by the "Corrective Action Due By:" date shown above, further enforcement will occur. Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well. Such a hearing may result in imposition of CIVIL PENALTIES for your violation of OCD rules.

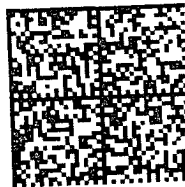
