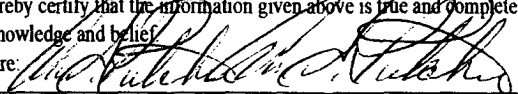

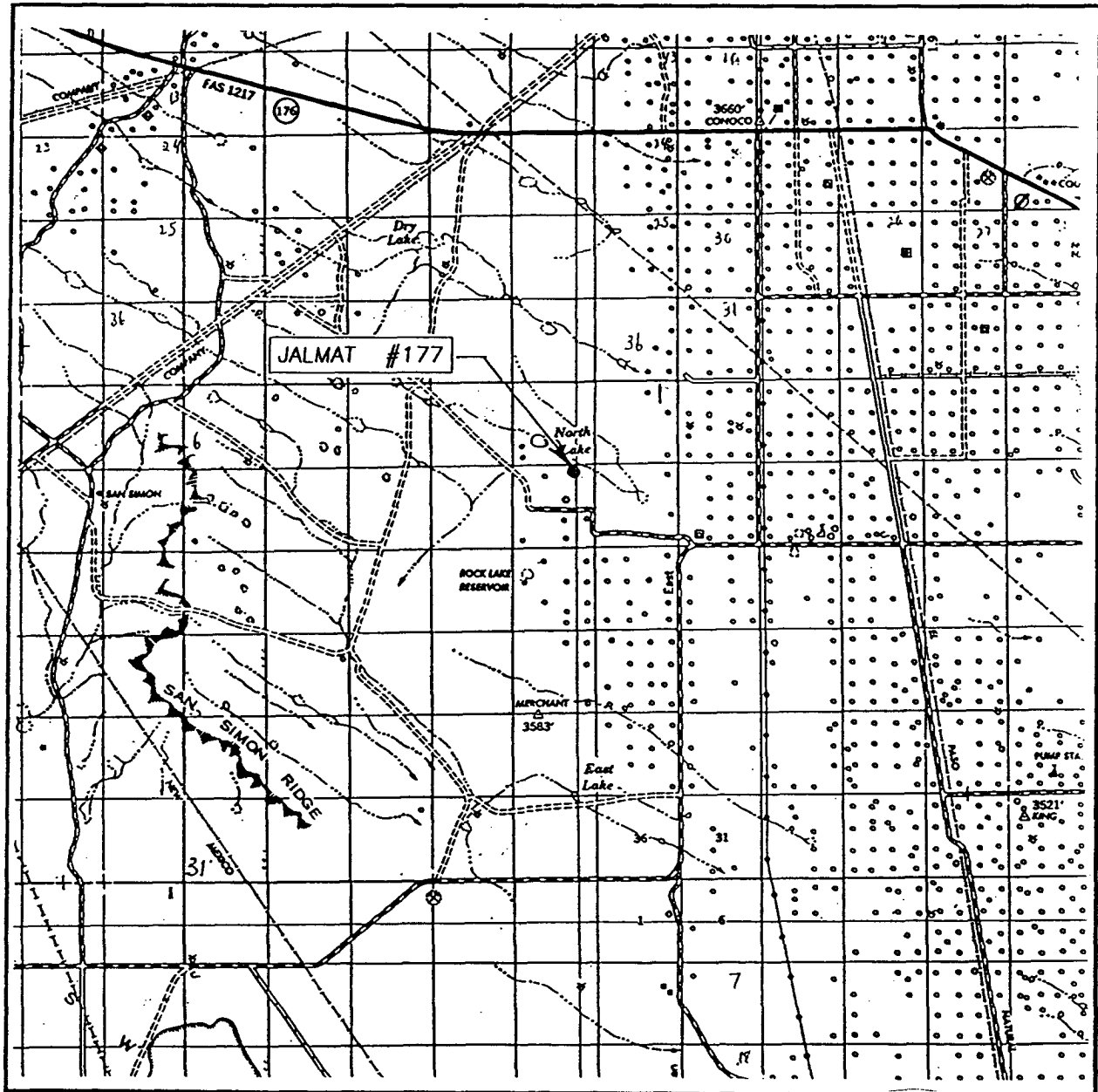

VICINITY MAP



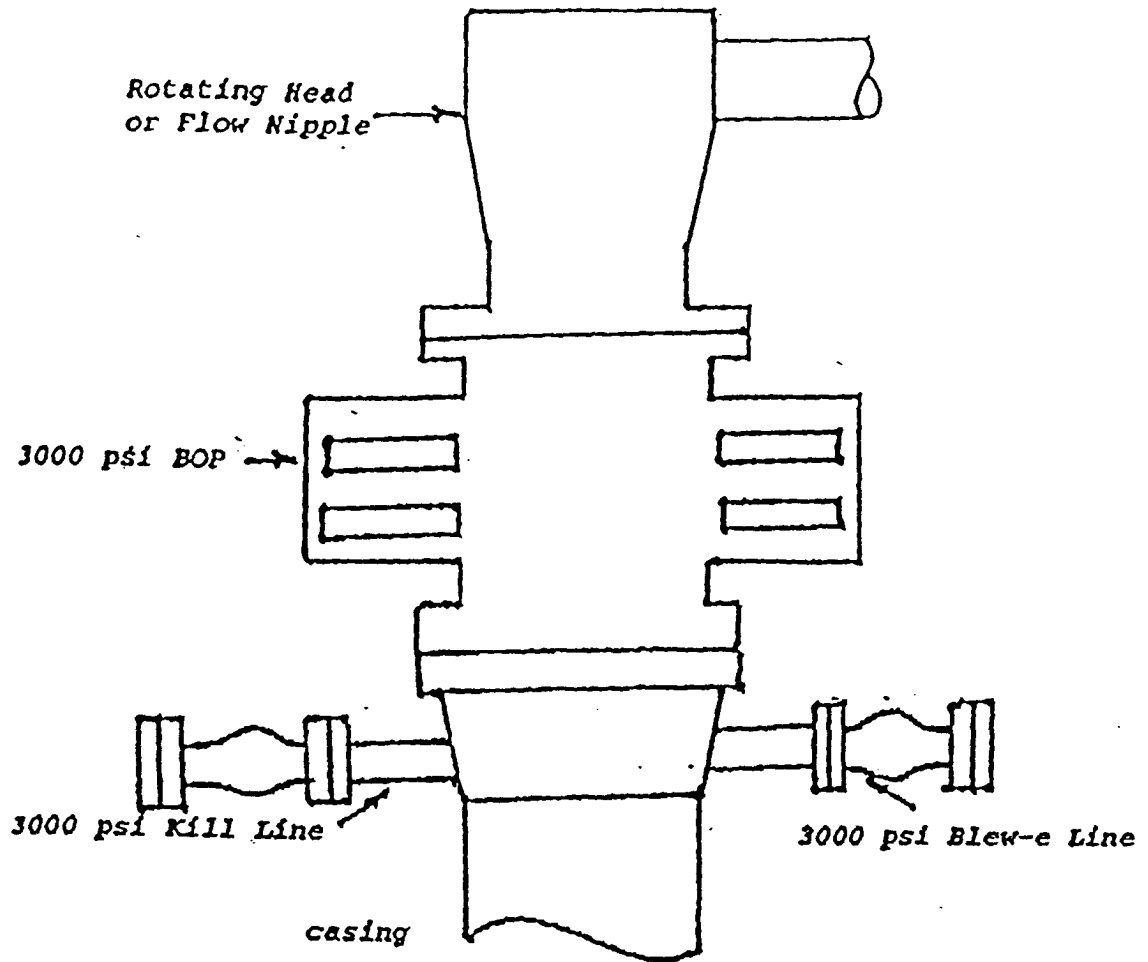
