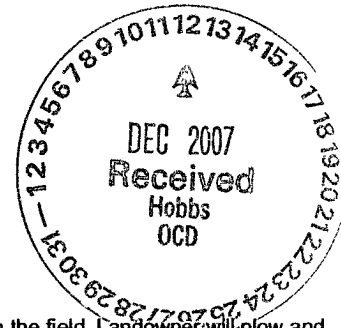

- Location has been cleared of miscellaneous equipment and trash.

Private surface owner has been contacted and approves of caliche from location being used to patch existing roads in the field. Landowner will plow and reseed surface to his liking.
