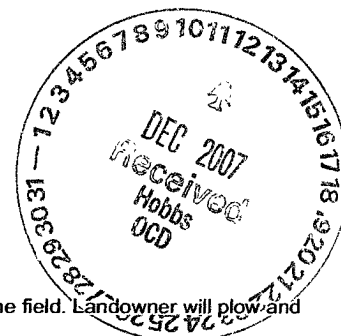

Private surface owner has been contacted and approves of caliche from location being used to patch existing roads in the field. Landowner will plow and reseed surface to his liking.
