Nadel and Gussman requests an extension of this well's TA status for a period of 12 months. This well was TA'D on Feb. 27, 2002. At that time a MIT test (copy attached) indicated no leaks. The BLM approved TA status for 12 months which ended on 2/27/2003. We requested an extension of the TA status on 8/19/04 and it was granted until 8/19/05. We would like to request that the TA status be granted until 10/18/08.

This well is only capable of producing from the Morrow and shares a 160 proration unit with the Big Lucky Lake #2 which is still active. Since this well shares a 160 acre proration unit we are not shutting in any production by keeping the well TA'D. Nadel and Gussman would prefer not to plug this well as we could use it to produce this proration unit should we lose the Big Lucky Lake #2 wellbore. Given the small volume of gas produced from this proration unit if we lost the Big Lucky Lake #2 we could not economically re drill the well but we could economically return the Big Lucky Lake #1 to production.
