Acidize Blinbry-Tubb perms 5054'-5986' with 7000 gal 15% NEFE HCL acid and 5000 gal gelled brine and 10,000 # rock salt at 9.5 BPM and 813#. Frac Blinbry-Tubb perms 5054'-5986' with 92,500 gal 25 # X-linked gel and 183,397 #'s 20/40 Badger Brown Sand at 38 BPM and 3465# average treating pressure. CO sand bridge at 5375'. CO frac sand fill from 5707-6010'. Run rods, pump and tbg. Put well back on production.
