This well has been TA'd for some time. Existing Bone Spring perfs 8941', 8944', 8945', 8962', 8963', 8966', 8967', 8968', 8970', 8972', 8975', 8976', and 8978' are below a CIBP set @ 8900' and above a cement retainer @ 8995'. The Bone Spring interval of 9001-9002', 9007-9010', 9013-9016', 9020-9024', 9027-9028', 9035', 9038', and 9041-9043' are below the cement retainer & were possibly plugged when cement was pumped below this retainer. Plan to drill out these two plugs and cement below the retainer to 9100'. Circulate hole clean then perforate &/or reperforate Bone Spring intervals 8995-9002', 9013-9016', 9020-9024', & 9042-9044'. RIH w packer to 8985' & test newly perferd interval. If needed will acidize w/ 6,000 gallons 15% NEFE @ 6 BPM & 6000 psi using 40 ball sealers. Then possibly frac this interval w/ 40,000 gal crosslinked gel & 75,000 lbs 20-40 sand @ 18 BPM & 7800 psi. Test & flowback. Then POOH w/packer & hang well on pump with all of Bone Spring interval open to production. Plan to MI Service Unit shortly to begin work.
