Request authority to recomplete well within the Blinebry & Tubb. It is planned to set a CIBP @ 6400' +/- & dump 35' cement on top, add perfs to the Blinebry @ 5505-5510' & 5605-5615' w/4 spf (60 holes) and the Tubb @ 6155-6165' and 6255-6265' w/4 spf (80 holes), then produce the downhole commingled production.

The work is to include the use of steel pits, therefore a permit will not be applicable.

Ref. NMOCD Administrative Order No. DHC-92 *Not for Tubb*, we request administrative approval to produce the downhole commingled Blinebry & Tubb production.
