The EBDU #38 is currently temporarily abandoned with Blinebry perms fr/5720-6036' and a RBP @ 5670'.

Apache proposes to reactivate this well via the following procedure:

1. Pull RBP @ 5670'.
2. Run bit and scraper to PBTD.
3. Acidize existing Blinebry perms fr/5720-6036' w/ approximately 10,000 gals HCl.
4. Swab back load.
5. Install production equipment.
6. Place well on Blinebry production.
