The EBDU #40 is currently temporarily abandoned with Blinbry perms fr/5808-5968' and a CIBP @ 5770'.

Apache proposes to reactivate this well via the following procedure:

1. Drill out CIBP @ 5770'.
2. Run bit and scraper to PBTD @ 5995'.
3. Acidize existing Blinbry perms fr/5808-5968' w/ approximately 8000 gals HCl.
4. Swab back load.
5. Install production equipment.
6. Place well on Blinbry production.

\* Well to be returned to prod by 6/1/08 or plans for plugging in.
