Notified NMOCD, Buddy Hill and BLM, Jim McCormick. MIRU Triple N rig #22 & plugging equipment, set steel working pit. Dig out cellar to 8" x 13" wellhead. Opened well, ND wellhead, NU BOP. Pulled vacuum on well (Pate trucking). RIH w/ 2" workstring and tagged existing CIBP @ 3,416'. RU cementer, circulated hole w/ 35 bbls plugging mud, and pumped 25 sx C cmt w/ 1% CaCl₂ 3,416 - 3,170'. PUH w/ tubing and pump 30 sx C cmt w/ 1% CaCl₂ @ 2,924'. PUH w/ tubing to 1,446'. SDFN. Will tag 03/28/08 per BLM.

03/28/08

Contacted BLM, Jim McCormick. Held tailgate safety meeting and sign in 8:00. RIH w/ tubing and tagged cmt @ 2,673'. PUH w/ tubing to 1,293', RU cementer, and pumped 25 sx C cmt w/ 2% CaCl₂ @ 1,293'. POOH w/ tubing and WOC 2 1/2 hrs. RIH w/ wireline and tagged cmt @ 1,010'. PUH and perforated csg @ 60', POOH w/ wireline. RIH w/ tubing @ 503' and circulated 65 sx C cmt 60' to surface inside 5 1/2" casing. SI 5 1/2 x 8" and circulated cement to surface in 5 1/2 x 8". POOH w/ tubing. ND BOP, and topped off wellbore w/ cmt. Washed up tools and BOP. RDMO to MLMU Unit #188.
