Acidize Blinbry-Tubb perms 5032'-5970' with 7000 gal 15% NEFE HCL acid and 5000 gal gelled brine and 10,000 # rock salt at 10 BPM and 2138#. Frac Blinbry-Tubb perms 5032'-5970' with 92,500 gal 25 # X-linked gel and 214,993 #'s 20/40 Badger Brown Sand at 39 BPM and 3067# average treating pressure. CO sand fill from 5820-6010'. Run rods, pump and tbg. Put well back on production.
