Sand Fracture stimulation to increase production. Tag PBTD at 5990' OK. Spot 2000 gal 15% NEFE HCL acid from 5958'-4779'. Perforate 7" casing with additional holes at 5060', 5066', 5119', 5273', 5346', 5400', 5472', 5720', 5756', 5850' w/ 1 SPF, 10 holes. Acidize Blinbry-Tubb perfs 4988-5954' with 5000 gal 15% NEFE HCL acid and 5000 gal gelled brine and 10,000 # rock salt and 70 ball sealers at 9.6 BPM and 1027#. Frac Blinbry-Tubb perfs 4988'-5954' with 92,500 gal 25 # X-linked gel and 220,000 #'s 20/40 Badger Brown Sand at 40.3 BPM and 3164#. CO sand fill from 5748-5990'. Run rods, pump and tbg. Put well back on production.
